#### **Building Committee Yearly Report: 2017**

We are in our new church facility as of mid-summer having had our official opening on September 15<sup>th</sup>. This was three years since the church building was lost in the Boles Creek fire. Much planning has gone into the structure and we had to deal with many code upgrades, phone calls or meetings with the contractor and architect as well as with the insurance agent. The end result has been that we have a wonderful fully paid for new church building.

God has truly blessed our congregation throughout the entire process. We still have to complete the landscaping around the building along with its watering system and install our new sign to indicate upcoming events, hours of services and other items of interest. The media system has additional microphones that we still have to install. The new building meets all of the required codes, is energy efficient has automatic lighting, a fire sprinkler system and many other automatic operating systems.

We now have three television monitors in the sanctuary which allow display of information such as song words, Bible verses, pictures and texts along with video information. This is all controlled from the booth at the rear of the sanctuary. Our new piano provides us with beautiful music for worship. The wall between the sanctuary and the fellowship is able to be folded up at the sides of the area opening the entire area for use when large activities require the space.

The building has two offices, a library, a state of the art kitchen, two Sunday school classrooms, a nursery located off the sanctuary, rest rooms and a patio located outside of the fellowship hall. We still are working on some problems with a new facility as some items do not work the same way they did in our old building.

We have been blessed in many ways throughout the entire process with the answers to many prayers and concerns throughout the process. Thanks to our God we were able to replace our building.
